- (a) Papers should be clearly typed on sturdy paper and double spaced. Three copies should be sent to the Editorial Committee of the Keio Economic Society, Keio University, 2-15-45 Mita, Minato-ku, Tokyo, Japan 108. The journal publishes articles in English in principle.
- (b) The first page of the paper should include:
 - (i) the title of the paper
 - (ii) an abstract with less than 100 words
 - (iii) the name and institutional affiliation of the author
- (c) Footnotes, especially those with complicated mathematical expressions, should be avoided as far as possible.
- (d) All references should be cited in the text by the author's surname and date of publication, e.g., Smith and Jones (1987) or Smith (1987). They should be listed at the end of the article in alphabetical order by author's surnames.
