Instructions for Authors

1. **Qualification:** Researchers and Ph. D. students working in fields relevant to the Global COE program 'Designing Governance for Civil Society'.
2. **Scope:** *JPSS* publishes articles related to civil society, governance, and democracy, and encourages contributions on these themes from various perspectives.
3. **Language:** Articles published in *JPSS* are normally in English, but editors are willing to consider contributions in other non-Japanese languages.
4. **Word Length:** Articles should be between 6,000 and 10,000 words in length including the abstract and endnotes. Authors should prepare an abstract of no more than 500 words in English.
5. **Deadlines:** *JPSS* is a semiannual journal. Submission deadlines are October 31st for the winter/spring issue and April 30th for the summer/autumn issue. In case of conditional acceptance, the editorial committee may decide to suspend the publication of contributions to future volumes.
6. **Review Process:** All articles undergo rigorous peer reviewing, normally by two anonymous referees who are experts in the field. If an article is accepted for publication, authors will be asked to make all necessary revisions and corrections to their article before publication.
