## Information for Authors

SCOPE. *Library and Information Science*, Journal of the Mita Society for Library and Information Science, publishes scholarly research papers and reviews and survey reports containing thoughts and findings not published previously in the fields of library and information science.

SUBMISSION OF MANUSCRIPTS. Authors are requested to submit their manuscript as files of Microsoft Word or PDF by e-mail to the Editorial Committee of Mita Society for Library and Information Science (e-mail address: lis-edit@ml.keio.jp). At least one person in the authors must be a member of the society.

ORGANIZATION OF MANUSCRIPT. Whenever possible, a manuscript should be presented in the following form: 1) title both in Japanese and English, 2) author's name with title and affiliation, 3) structured abstract (purpose, method, results) in English (not exceed 250 words) and its Japanese translation, 4) text including a) introduction, which should set the objective and scope of the paper, b) methods and materials should be presented in detail so that readers can adapt or pursue them further, c) results or new data, d) discussion and examination of the results, e) conclusion or new theory with evaluation of the findings or development, 5) literature cited, with exact bibliographical entries, and 6) figures and tables. The manuscript must be no longer than 12,000 words excluding the abstract, figures, tables, acknowledgments and references.

EDITING. Minor revisions may, without permission of the author, be made by the Editorial Committee members to remove ambiguities. When extensive editing is needed, a manuscript will be returned to the author for revision and resubmission.

PREPARATION OF TYPESCRIPT COPY. Manuscript should be prepared as neatly as possible in the form used by Library and Information Science. Type-Scripts should be double-spaced and submitted, if possible, in duplicates.

REFERENCES. They should be double-spaced on a separate sheet in the order of their citation in the text and numbered consecutively. In the text they will be cited as numbers within parentheses on the text line. There shall be no footnotes, but notes may be included in the "References."

FIGURES, TABLES. Figures should be clear and neat so that they can be reproduced easily. Tables should be typed on a separate sheet, given a caption and cited in the text.

FREE COPIES. Twenty off-prints and a copy of the issue which contains the article will be presented free to the author. If arrangements were made before the Journal is printed additional off-prints can be provided at cost.
