## Extracts from Contribution Rules

- 1. The contributor to the present university proceedings must as a rule be a member of staff of the Faculty of Engineering. But in the case of joint research works or of research admitted by the editorial committee, the manuscripts written by any other person concerned with Keio University can also be accepted.
- 2. The manuscripts must be the original work of the contributor, and must be written in European languages.

For manuscripts which have already appeared in other publications, the following rules apply:

- (1) A manuscript previously published in Japanese in a Japanese Journal must be contributed within a year of its first publication to be accepted. The name and the pages of the publication in which the original copy has been published must be indicated in a footnote.
- (2) A manuscript previously published in European languages in a Japanese or a foreign journal must also be contributed within a year of its first publication for its abridged or developed form to be accepted as an article in the present proceedings.

The name and the pages of the publication in which the original copy has been published must be indicated in a footnote.

- (3) In the case of research work which is to be accepted as an article in the present proceedings and which has been published more than a year previously, the investigation and admission of the present committee is required for its acceptance.
- 3. The date for acceptance of manuscripts shall be the date of the manuscripts arrival at the present committee.
- 4. Decisions on the acceptance or rejection of manuscripts shall be made by the present committee.
