## Instructions for Authors

An author must in principle be a member of the Faculty of Engineering, Keio University. A non-member author is required to receive permission from the Editorial Board for his paper to be accepted for publication.

A manuscript, written in either English, German, or French, must be original. However, an author may contribute, with an appropriate reference to the original publication, the translation in any of the above languages of his paper that appeared elsewhere in Japanese less than a year previously.

The Editorial Board reserves the right to return a manuscript for rewriting or any alterations.

A manuscript should neatly be typewritten double-spaced on standard size papers with ample side margins and be in less than 30 pages including attached tables and figures.

A manuscript should contain title, author (in alphabet and in Japanese Kanji), abstract, text and references in that order.

Each paper must have an English abstract. The abstract should not be a mere amplification of the title but a concise representation of contents and conclusions.

References should be grouped at the end of a paper with consecutive numbers.

Each reference must contain the following information:

From journals: author, title of article, journal (*italic*), volume (*gothic*), year of publication, pagination.

From books: author, title of book (*italic*), publisher, year of publication, pagination (if necessary).

*ex.* 1. Bradley, R. G., Approximate solutions for compressible turbulent boundary layers in three dimensional flow, *AIAA J.*, **3**, 1968, 859-63.

2. Kaskhodoff, N. M., *Electronic drafting and design*, prentice-Hall, 1966, 594p.

An author may abbreviate journal titles according to the way used or proposed by the society to which he belongs.

Separate tables and figures must carry an author's name, consecutive numbers and the instruction of place to be inserted in a text on margin available.

A total of 50 reprints will be provided free of charge to the author. Additional request will be accepted on a cost reimbursement basis.
